AUDIT

TAX ADVISORY

Golf clubs present specific issues in relation to VAT. It usually involves an additional cost given that certain services related to the practice of sports are exempt from this tax, consequently, the VAT payments borne by these entities are not fully deductible.

Another aspect to consider, depending on the legal form and investment structure that has been implemented, are transfer pricing, since many clubs have separate entities to own the property and run the club.

If your organization is an association or club, it is important to determine the regime applicable to income earned from membership, contributions, and other activities, since some may be exempt from Corporation Tax while others tend to pose more difficulties.



SUSTAINABILITY AND CORPORATE SOCIAL RESPONSIBILITY

Corporate Social Responsibility (CSR) is a management model based on the incorporation of certain environmental and social criteria in the organization's decision-making.
